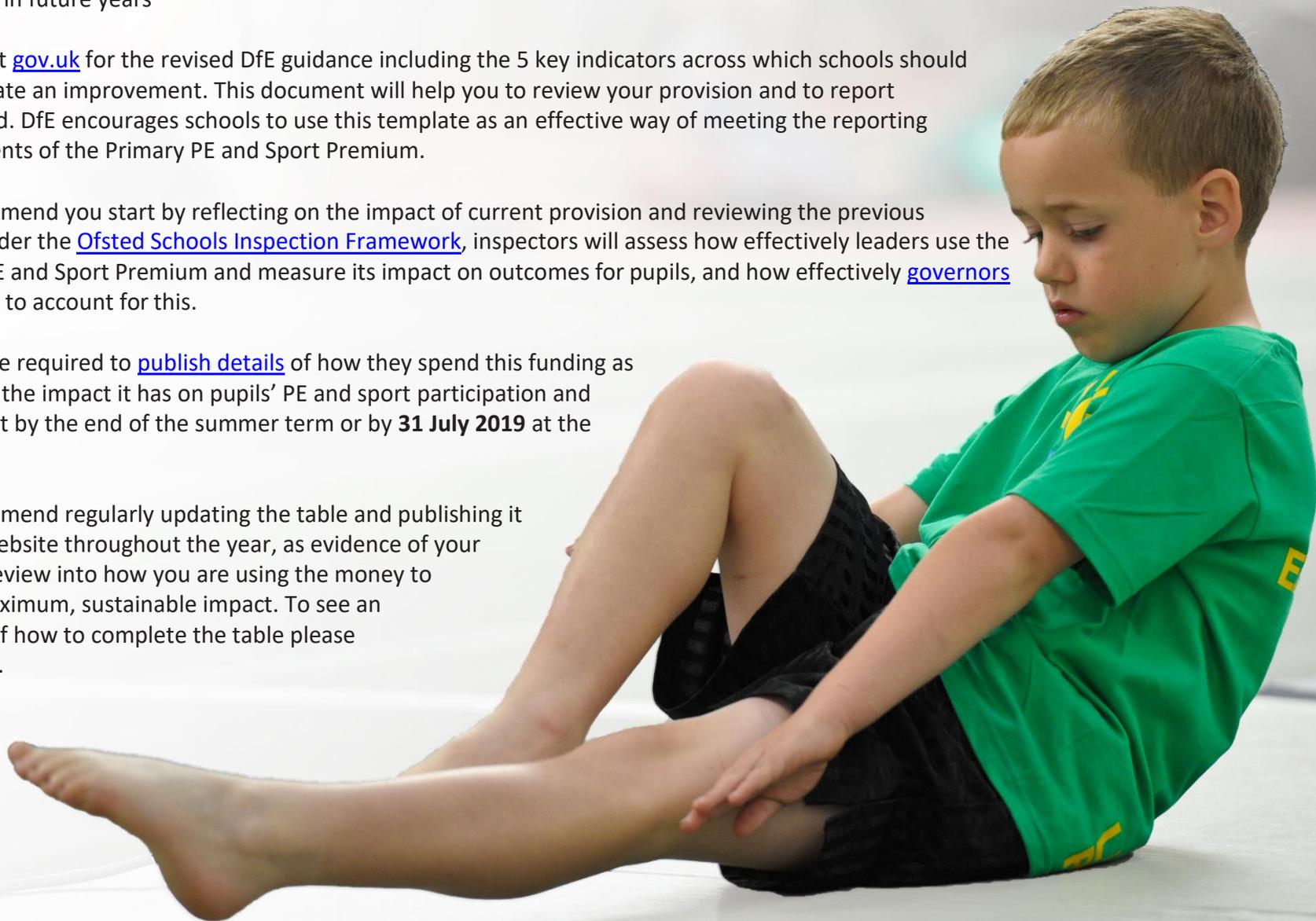
- Develop or add to the PESPA activities that your school already offer

To provide the children with swimming lessons on a weekly basis, across the Autumn Term.
