Dear Parent / Carer,

I hope you and your family are well. Thank you for your continued support and understanding as we collectively handle the challenges posed by Covid-19.

You will no doubt have seen the Prime Minister's announcement that primary schools will fully re-open, for all pupils, on Monday 8th March. We are very much looking forward to having all children back in our academy, and want to assure you that, this has been the case throughout the coronavirus crisis. We will ensure the academy is as safe as it possibly can be. Your child's health, and the health of all our pupils and staff, is the most important factor always for us.

There are a number of specific points about the full return to school that I wanted to set out in this letter, which I hope are helpful.

Testing

- Primary school children will not be required to be tested for Covid-19 when schools re-open to all pupils on Monday 8th March.
- However, any child who develops Covid-19 symptoms should self-isolate immediately, as now, according to Government guidelines.
- Our staff will continue to test themselves at home and will be provided with two rapid Covid-19 tests each week.

Face coverings

- Primary school children do not need to wear a face covering when in school.
- However, the Government has recommended that face coverings should be worn by primary school staff and adult visitors in situations where social distancing between adults is not possible (for example, when moving around in corridors and communal areas). This policy will be reviewed over the Easter Holidays so is in place until at least the end of term.
- Therefore, when visiting the school, please use a face covering.

Clubs and After-School Provision

- From Monday 8th March, we will be offering a breakfast club, based on the same arrangements as before lockdown began, therefore, if your child attended breakfast club before lockdown, your child will continue to have a place. Unfortunately, however, After School Clubs will not be returning until Summer term.

On Monday 8th March, children will be welcomed back in to our Academy via the staggered start and finish times that were in place prior to the current lockdown. A reminder of these times will be sent out to you separately. We will also continue to take children's temperatures before they enter the building. We have not made any changes to our current risk assessments, therefore all arrangements that were in place before lockdown will remain until further notice.

Breakfast club will also resume the same as prior to the current lockdown, places are available to Key Worker and Vulnerable children only and will continue under a bubble system. Spaces need to be approved prior to attendance, with proof of Key Worker status provided. The Government's announcement indicates we are tentatively returning to normal. However, I want to reiterate how alert we are to the continued risk of Covid-19. We will continue to adhere to stringent health and safety measures now, and when fully open. Your support in helping us be as safe as possible is much appreciated and will help ensure we stay open to all pupils, and keep your child, our staff, and you, safe.

I hope this letter is helpful, and reassuring, and we look forward to seeing you all on 8th March.
